Report of the Expert Team on Education, Training and Competency (ET-ETC)

(Submitted by Chris Webster and Kathy-Ann Caesar, ET-ETC Co-Chairs)

Summary and Purpose of Document

This document provides an overview of the activities of the ET-ETC since the last meeting of the CAeM Management Group held 8 to 10 November 2016 together with detailed information on the working arrangements and work plan of the expert team.

1. EXECUTIVE SUMMARY

Standards of AMP Competency and Qualification

1.1 The past four years has seen the passing of two significant milestones for aeronautical meteorological personnel (AMP). On 1 December 2013, the aeronautical meteorological observers (AMO) and aeronautical meteorological forecasters (AMF) competency standards came into force, and on 1 December 2016 the AMF qualification standard came into force.

1.2 A key role of the ET-ETC during this period has been to guide, coordinate and encourage all organisations in the international AMP community in their efforts to comply.

1.3 Because CAeM has pioneered this work, experts from other technical areas have looked to CAeM for advice on how they can implement comparable systems. The team has always been responsive to such needs.

WMO Guide on Competency

1.4 ET-ETC and the WMO ETR Office have developed a WMO Guide on Competency, under the expert leadership of Andrea Henderson of the Australian Bureau of Meteorology. The Guide will meet a great need within the international community.

1.5 The Guide will include general material on defining and writing competencies, implementing competency frameworks that meet organizational needs, assessing for competencies, competency-based training and QMS-compliance. It will interface with examples of competency frameworks.

Education, training and competency websites

1.6 The <u>CAeM Moodle website</u> has been progressively upgraded, and new materials added, with continued kind technical support from the UK Met Office. A review of the currency of material on this site is ongoing.

1.7 CAeM developed a Competency Assessment Toolkit in the previous intersessional period to assist with the introduction of the competency frameworks that were new at the time. In 2017 ET-ETC reviewed and updated this toolkit, with the kind assistance of Hong Kong Observatory. See: <u>http://forum.14.caem.wmo.int/post14web/tt_cat/</u>.

2. **PROGRESS/ACTIVITY REPORT**

WMO Guide on Competency (Tasks 2.1.1 and 4.1.4)

2.1 A final draft of this document was completed in 2017. Andrea Henderson led the work, in consultation with the WMO ETR Office and many other experts.

2.2 The document is currently with WMO Publications. It is anticipated to be published as an electronic document in English only by end January 2018. It has been decided to split the competency frameworks into a separate publication as these are likely to be more dynamic than the body of the Guide. The separate publication will be titled a Compendium of WMO Competency Frameworks (or similar) and given a separate document number. 2.3 ET-ETC has contributed to discussions on the introduction of competency-based frameworks for various areas where AMF may be working, e.g. Space weather and volcanic ash forecasting. More discussion will be required.

Maintenance and upgrade of moodle website (Task 2.1.3)

2.4 The CAeM education and training website (<u>http://www.caem.wmo.int/moodle/</u>) was upgraded to "moodle" version 3.1 in November 2016, under the supervision of Raf Windmolders and Ian Dale.

2.5 During 2017 the ET-ETC investigated transforming the website to a more contemporary version, based on valuable advice from Australian Bureau of Meteorology. Good progress was made in implementing the upgrade, kindly provided by colleagues of Kathy-Ann Caesar at CIMH. The work is viewable at http://caem.cimh.edu.bb/moodle/. Unfortunately, due to organisational staff changes, progress has recently stalled.

2.6 The team checked and updated all links from the moodle website in July 2017.

2.7 The UK Met Office College reviewed the content of publication WMO-No. 1390 "Aviation Hazards" (ETR-20) in April 2017. Their opinion was that it was in good shape, but that the lee wave/mountain wave section should be less location-specific. The document was subsequently updated in December 2017, and will shortly be uploaded to the moodle website.

2.8 Andrea Henderson and Michael Graf have agreed to review the currency of material on the website or linked from it, by end February 2018. In the future, this action will be scheduled to take place during each intersessional period.

Achieving 1 December 2016 qualification deadline for AMF (Task 3.1.1)

2.9 Jannie Stander reported an awakening and upswing of requests for guidance from mainly African states. The team has offered Jannie assistance as the need arises.

2.10 The ET-ETC is interested in the results of the survey sent by ET-GOV in 2016, as they pertain to qualifications and competency.

Review and Update of the Competency Assessment Toolkit (Task 3.2.1)

2.11 The original Competency Assessment Toolkit was developed by CAeM in the previous intersessional period to assist with the introduction of the competency frameworks that were new at the time. The team reviewed and updated the toolkit in August 2017, with the kind assistance of Queenie Lam and her colleagues at Hong Kong Observatory.

Workshops (Task 3.2.2)

2.12 Paul Bugeac and Jannie Stander delivered a successful competency assessment workshop in November 2016 at the RTC-Qatar.
