I have pleasure in informing you that Japan will organize a WMO Volcanic Ash Advisory Centre (VAAC) "Best Practice" Workshop 2017, which will be held at the Japan Meteorological Agency (JMA) in Tokyo, from Wednesday 7 to Friday 9 June 2017.
