Although E-ASAP is a mandatory programme, seventeen EUMETNET Members are participating in E-SURFMAR which is optional. E-SURFMAR (Surface Marine Programme) concerns the European VOS and Data Buoys. EUMETNET members are Austria, Belgium, Croatia, Cyprus, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Luxembourg, the Netherlands, Norway, Poland, Portugal, Serbia, Slovenia, Spain, Sweden, Switzerland, the United Kingdom of Great Britain and Northern Ireland, the Czech Republic, Montenegro, and the Former Yugoslav Republic of Macedonia.
