## THIRD SESSION OF THE RA V MANAGEMENT GROUP

## (Geneva, 5 and 12 June 2009)

### 1. **OPENING OF THE SESSION (AGENDA ITEM 1)**

1.1 The third session of the RA V Management Group (MG-3) was held at the WMO Secretariat on Friday, 5 and Friday, 12 June 2009 during the sixty-first session of the Executive Council. The list of participants is attached as Annex I to this report.

1.2 The session was opened at 08:00 hours on 5 June 2009. Mr A. Ngari, president of RA V, who chaired the session, extended a warm welcome to all participants and thanked the members for accepting his invitation to attend the meeting. He also thanked the Secretariat for the arrangements made in organizing this session. Dr T. Toya, Regional Director for Asia and the South-West Pacific also welcomed the participants and expressed his appreciation to the MG for its substantial work resulting in successful outcomes of the MG-Ext session (Kuala Lumpur, 20-24 April 2009), and hoped for further successful outcomes for the preparation of XV-RA V session in Indonesia in April/May 2010.

1.3 The MG adopted the agenda of the session, which is given in Annex II to this report.

#### 2. MATTERS ARISING FROM THE SECOND AND EXTRAORDINARY SESSIONS OF THE RA V MANAGEMENT GROUP (AGENDA ITEM 2)

2.1 The Group reviewed the follow-up actions arising from the second session of RA V Management Group (RA V MG-2) held in Geneva on 23 June 2008, which were addressed in detail as follows.

2.2 The Group was pleased to note the progress of a VCP coordinated project, financially supported by the USA, for the provision of Low Rate User Stations (LRUSs) to enable the Island Developing States in the Pacific to allow access to meteorological satellite images in Low Rate Information Transmission (LRIT) format. Under this project, 18 LRIT receivers and software were procured at the end of June 2008 and delivered to 16 benefiting countries and territories by May 2009. The purchase of other relevant equipment, including antennas, PCs and peripherals, and the installation and training are in process. The first installation and training is expected in August 2009.

2.3 The Group was also informed that the Government of Finland approved two project proposals for the Pacific SIDS under a special funding instrument, Institutional Cooperation Instrument (ICI) within a total amount of EUR 500,000 for: (1) Quality Management System (QMS) implementation support to the Pacific NMSs; and (2) support to SPREP in the development of a regional socio-economic impact study of meteorological services and update of a regional development and financial plan for the Pacific for the development of meteorology in the region. The main activities would be workshops in Samoa, Tonga and Kiribati and support in development activities associated with the project. The first Aviation QMS Implementation Project Workshop is planned for August/September 2009 in Apia, Samoa. In this connection, a coordination meeting was held in late May 2009 in the WMO Secretariat with the Finnish Meteorological Institute representatives for the implementation of QMS workshops.

2.4 The Group, considering that the follow up to the RA V MG-Ext (April 2009) is the main issue for discussion, agreed that the matters arising from MG-Ext be discussed under relevant agenda items 3 to 6.

## 3. REVIEW OF THE WORK OF THE RA V SUBSIDIARY BODIES (AGENDA ITEM 3)

The Group considered the plan for the budgeted regional events of RA V during the fifteenth financial period (2008-2011) as given in Annex III. It noted that the session of the Working Group on Climate-related Matters is planned in late October 2009 in Nadi, Fiji; and the session of the Working Group on the Planning and Implementation of the WWW is planned for 30 November to 4 December 2009 in Honolulu, USA with the participation of core members of the Working Group on Natural Disaster Prevention and Mitigation (WG-DPM); and the session of the Working Group on Hydrology is proposed to be held in early March 2010.

The Group requested the Secretariat to finalize the plan of the meetings of the subsidiary bodies of RA V in consultation with Members that have indicated their willingness to host the meetings, taking into account the possible improvement in RA V working mechanism in accordance with the WMO Strategic Plan 2008-2011 and draft RA V Strategic Plan (2009-2011).

## 4. DEVELOPMENT OF A STRATEGIC PLAN FOR RAV (AGENDA ITEM 4)

4.1 The Group was informed by Mr G. Foley, Chair of the Task Team, of the progress on the development of the RA V Strategic Plan (2009-2011), with reference to the recommendations from the fifth RA V Technical Conference (Kuala Lumpur, 20-24 April 2009), in particular the need for streamlining the proposed deliverables and highlighting high-priority achievable deliverables.

4.2 The Group was pleased to note that the updated draft Strategic Plan identified 35 Regional Expected Results and 87 deliverables (streamlined from 37 Regional Expected Results and 173 deliverables of the previous version). It requested the Task Team members to review and finalize the draft Strategic Plan by the end of August 2009 in light of identifying realistic deliverables and taking into account WMO strategic planning cycle.

4.3 The Group further requested the Task Team to continue to develop its Action Plan by the end of 2009 by proposing concrete action for each corresponding deliverable, in collaboration with Working Group Chairs, in particular with the Chair of Working Group on Hydrology. A complete RA V Strategic Plan would be composed of the executive summary; introduction; regional priorities; review of the implementation of strategic goals; purpose, vision and mission of Strategic Plan; Strategic Plan for the enhancement of NMHSs in RA V (2009-2011); and its Action Plan.

4.4 The MG-3 reiterated the need for developing survey questionnaires to monitor the implementation of the Strategic Plan and Action Plan. It also requested the Task Team to develop such questionnaires on the basic capability of NMHSs in RA V to be completed by Members for submission to the Secretariat by the end of 2009.

## 5. ORGANIZATION OF THE FIFTEENTH SESSION OF REGIONAL ASSOCIATION V (XV-RA V)

5.1 The Group expressed its appreciation for the kind offer of the Government of Indonesia to host the XV-RA V session in Bali, Indonesia from Friday, 30 April to Thursday, 6 May 2010 (seven days), preceded by a four-day RA V Tropical Cyclone Committee from Monday, 26 to Thursday, 29 April 2010, which was rescheduled one week later taking into consideration the concerns expressed during MG-Ext session and the 13<sup>th</sup> session of the Regional Meteorological Services Directors (Nadi, Fiji, 5-8 May 2009) about having the TCC meeting during the Tropical Cyclone season.

5.2 The Group further considered the Provisional Agenda and Work Plan. The MG-3 agreed with the Provisional Agenda and Tentative Work Plan as per attached in Annexes IV and V, respectively.

5.3 The MG-3 agreed that the QMS and maintenance issues would be possible subitems under agenda item 6 – Emerging Issues and Specific Challenges. The president urged Management Group members to propose to the president and the Secretariat additional specific emerging issues and challenges in RA V, if any, before the end of September 2009.

5.4 Following the discussions during the Mg-Ext session, in view of the agreed time allocation of two hours in total for Scientific Lectures, the MG-3 considered that three or four scientific lectures could be presented under the following three topics during the XV-RA V session: (1) adaptation to climate change; (2) natural disaster risk reduction; and (3) the use of new technologies for forecasting, including the Ensemble Prediction System (EPS). The Group requested the WMO Secretariat to invite Members to submit to the president titles and abstracts of potential scientific lectures before the end of November 2009.

5.5 The Group noted that a pre-session visit by the WMO conference officer to Jakarta and Bali is planned for October 2009 and requested the Secretariat to prepare the Information Note for Participants (XV-RAV/INF. 1 – Material arrangements) as early as possible after the pre-session visit in collaboration with the Local Organizing Committee (LOC).

## 6. FUTURE WORKING MECHNISM OF THE ASSOCIATION

6.1 The Group noted several possible approaches for developing more efficient working mechanism of the Association, with a focus on the experiences in XIV-RA II (December 2008) and XV-RA IV (April 2009).

6.2 It noted that RA II took a comprehensive approach to cover all priority areas of the Association by establishing four Working Groups on: WMO Integrated Observing System and System (WG-IOS/WIS); Climate Services, WMO Information Adaptation and Agrometeorology (WGCAA); Hydrological Forecasts and Assessments (WGH); and Disaster Risk Reduction and Service Delivery (WGDRS), and the Management Group in alignment with Strategic Thrusts and Expected Results of the WMO Strategic Plan as well as Expected Results of RA II Strategic Plan. The established Working Groups maintain strong linkages with the existing Technical Commissions. RA II identified Chairpersons, Coordinators and Theme Leaders of the Working Groups, and all the volunteer experts were also mapped to work with relevant Theme Leaders. The terms of reference for each Working Group were agreed by the XIV-RA II session.

6.3 RA IV took a flexible approach to focus on regional priority issues by establishing the Management Group, Hurricane Committee and activity-oriented Task Teams to focus on: the development of a WIS/WIGOS Regional Radar Demonstration Project; the development of a Regional Climate Centre; RA IV DRR pilot projects; ICAO requirements for aviation meteorology; RA IV input to the WMO Strategic Plan and development of the RA IV Operating Plan; and identification of RA IV training needs and the gaps in available resources to meet these needs. In view of the need to maintain linkages with WMO constituent bodies, the Secretariat and other organizations, RA IV requested the president to identify focal points who can serve in areas to be determined by the Management Group.

6.4 In view of the above, and further to the discussions during MG-Ext, which considered the comprehensive approach with the establishment of the Management Group and four Working Groups, and the Tropical Cyclone Committee for the South Pacific and the South-East Indian Ocean to be appropriate for future working mechanism of RA V, the MG-3 recognized some advantages of an action-oriented Task Team approach. The Group

considered that in either approach the priority areas for RA V to focus on would include: (1) Communications; (2) QMS in aviation services; (3) RA V Severe Weather Forecasting and Disaster Risk Reduction Demonstration Project (SWFDDP); (4) Regional Climate Centre(s); (5) RSMC Nadi and SPREP Review; and (6) RA V Strategic Plan and Action Plan. It agreed on the need for identifying the necessary expertise to work for the above priority areas in the region.

6.5 The Group agreed that the Terms of Reference for Working Groups/Task Teams be prepared for concurrence by the XV-RA V session. It further agreed to continue consideration of the most appropriate future working mechanism via e-mail to enable preparation of the relevant document (XV-RA V/Doc. 5.1) in January 2010.

## 7. OTHER BUSINESS

7.1 The RA V MG-3 was briefed on a WMO-World Bank-UNISDR initiative of a project for hydrometeorological study (consultancy services) for countries in Southeast Asia including Indonesia and Philippines. The existing capacity and capacity-strengthening needs (human, institutional and equipment) of NMHSs will be identified for each ASEAN member country, taking into account a regional approach in data sharing and analysis.

## 8. CLOSURE OF THE SESSION

8.1 The third session of the RA V Management Group was closed at 09:00 on 12 June 2009.
