## Request for assistance under the WMO Voluntary Co-operation Programme (VCP)

1. **WMO Member:** Republic of Vanuatu
2. **National agency responsible for initiating the request:** Vanuatu Meteorological and Geohazard Department (VMGD)
3. **Title of project:** Rehabilitation of Aneityum Meteorological Station (RBSN/RCBN/WMO Station No. 91568)
4. **Purpose and description of project**

The purpose of the project is to rehabilitate and upgrade meteorological equipment for Aneityum Meteorological station (RBSN/RCBN/WMO Station No. 91565)

The specific objective of the project is to purchase and install new meteorological equipment at Aneityum Meteorological station (RBSN/RCBN/WMO Station No. 91565)

The project will be implemented in three (3) components, namely, (i) Component 1: Procurement of equipment; (ii) Component 2: Installation of equipment and; (iii) Component 3: Managing and reporting on progress of project's implementation.
5. **Reason why other sources of assistance cannot be expected**

With the current economic and financial situations it is unlikely that the Government will provide funding for the project. Other sources of assistance cannot be expected.
6. **Explanation of how the project is related to a WMO programme and outline of the national development plan including related procurement plans from other sources, and existing facilities and expertise**

The project is related to VMGD 2012 Business Plan in particular with the objective to ensure observation equipment and networks meet WMO and ICAO standards and requirements.
7. **Global, regional or national benefits to be expected from the project and degree of urgency**

Globally and regionally, the project will improve the quality and availability of data Whitegrass Airport Meteorological Stations

At the national level, the project will make readily available meteorological data on a regular basis to national, regional and international communities, hence meeting Vanuatu obligations under international agreements such as WMO convention, UNFCCC, etc; and tropical cyclone warning purposes.
8. **Nature and scope of national contribution to project, in particular as far as continuous operation of the equipment provided is concerned**

The national contribution will consist of availability of land, technician to install equipment, and managing and reporting on the project's implementation.
9. **Estimated duration to complete project, including, if any**

4 months, and it will include procurement, testing and installation of equipment.
10. **Nature and scope of VCP assistance requested including the estimated cost, if available, of the project and of the proposed VCP contribution with detailed description and the estimated cost of each item**

The Government of Vanuatu is requesting the WMO Secretariat for financial assistance through the VCP to purchase and install meteorological equipment for Whitegrass Airport Meteorological Station. The list of needed equipment and related estimated costs are presented in Table 1 below.
