7. Input to the development of a Project Implementation Plan

The Meeting will provide input on the development of a Regional Project Implementation Plan, which would include for example, detailed specifications for data and products to be exchanged, performance measurements, review and reporting. The Project Implementation Plan is intended for the use by the organization of each regional subproject which includes participation by Global and Regional NWP Centres, NMHSs and National organizations for disaster management and civil protection.
